Minutes of the January 29, 2015 Annual Meeting of the Rock Island County Bar Association

The 2015 Annual Meeting of the Rock Island County Bar Association was held at the Stoney Creek Inn & Conference Center on January 29, 2015 with a quorum of members in attendance. President Judge Ted Kutsunis presided over the meeting. President Kutsunis called the meeting to order at 7:15pm by introducing Judges and guests in attendance.

Guest of Robert Park, James McCluskey, addressed the Association as a candidate for the 3rd VP position of the ISBA.

Secretary Treasurer Mark Churchill addressed the Association regarding the 2014 Financial Statements. He advised that the decrease in revenue in 2014 was the result of only 1 billing going out to members for dues instead of the customary 2 or 3 and that delinquent dues will be collected in 2015. Sec/Treas Churchill also advised that the net amount received by the Association for hosting the 2014 Law Day Seminar was \$1,159.13 and that the net amount received by the Association for the 2014 Fall CLE Seminar was \$1,631.26. The 2014 Financial Statement of the Association, also set forth in THE OATH, were approved unanimously by voice vote.

President Kutsunis acknowledged the success of the 2014 October CLE Seminar presented by the Association and thanked co-chairs Bob Park and Mike Warner for their efforts. The Seminar was very well received and appreciated. Bob Park indicated he and Mr. Warner's intent to put on another seminar this fall.
